ORDER

The Directorate of Survey and Settlement, Puducherry is supplying village Maps, Region Maps, Taluk Maps, FMBs, to the needy on payment of prescribed fees. The Survey Directorate renders services like sub-dividing a portion of an existing land, pointing out recorded boundaries and fees collected. The rates collected was fixed in the year 1988 and later revised in the year 1996.

2. The Lieutenant Governor is pleased to order revision of rates for various supplies and services with immediate effect as detailed below.

Sl. No.	Item	Rate
1.	Sub-dividing a portion of an existing land	Rs.75/-
2.	Pointing out each recorded boundary.	Rs.25/- per F line.
3.	Cost of Village maps	Rs.75/- per unit sheet
4.	Cost of Region maps (Colour)	Rs.80/- per unit sheet
5.	FMB for one sub-division	Rs.25/-
6.	Cost of Region Map (B/W)	Rs.75/- per unit sheet
7.	FMB per field	Rs.75 /-
8.	Cost of Taluk Maps	Rs.75 per unit sheet


The Measurement charges on Appeal or second time measurement shall be double the rate fixed.

3. The rates will be applicable to Central Government, States and Union Territories, Institutions, Boards, Societies, Corporation and local bodies also.

4. The revenue which will accrue on account of the above sales and services is creditable to the Receipt Head "0029-Land Revenue - 800-Other receipts (2) Directorate of Survey And Land Records - Sale of Maps, etc."
